# V. Reports of Officers -

Tom Mazzaccaro - President

Tom thanked the Board for his reappointment as President for 2017. He welcomed Linda Peskin and advised that he and Allan met with her for an in depth orientation. The carpeting and classroom projects will be completed this year. The Township will be keeping track of absences by Board members via an attendance sheet. Carmen Allora – Treasurer

Carmen stated that normalized budget attainment is at 100%. Year to date revenue is on target 100% of annual budget. Year to date operating expenditures are \$1,485,825.00 or 90% of annual budget. Included in expenditures is year to date salaries and temporary help which are at \$613,039.00 or 97.6% of their combined budget. The year to date operating budget surplus is \$163,373.00 and year to date capital expenditures are \$227,159.00 or 91.4% of annual budget. Total capital and operating expenditures have reduced the budget surplus revenue to \$63,786.00 YTD.

A few new line items will be added to Edmunds spreadsheet for 2017.

Robert Donohue – Assistant Treasurer

Robert stated the reports should be in the correct format this upcoming year.

# VI. Report of Board Attorney – Brian thanked the Board for the reappointment.

# VII. Report of Liaisons

Mayor – Mayor Sandham thanked the Trustees for their work. The Township kicked off the 150<sup>th</sup> Anniversary with the Reorganizational Meeting and a party and the remodeling of the Chamber room. An employee luncheon will be held on April 11. One Montville is sponsoring a day of respect and community service on January 16<sup>th</sup> with a walk that will

go from Town Hall to the Pine Brook Jewish Center and conclude with a bus trip to other houses of worship.
